

GRUPO SPORTS WORLD ANNOUNCES THE REOPENING OF ITS CLUB SW PASEO INTERLOMAS

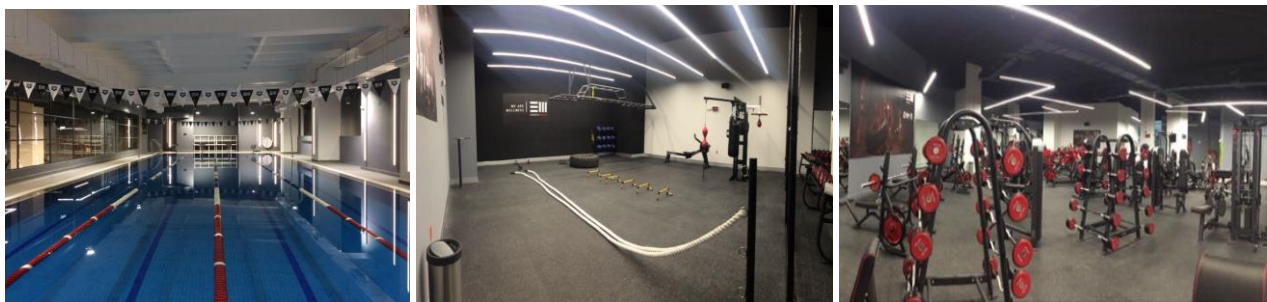
In July 2016, the Company announced the closure of its club SW Paseo Interlomas Club due to the remodeling of the shopping center Paseo Interlomas, located in Vialidad de La Barranca 6, Bosque de las Palmas, in Huixquilucan district. This exclusive mixed-use complex is found in one of the busiest areas of Interlomas. With the remodeling, 29,000 m² of commercial area were added. In addition, the complex will have a hotel and more than 22,000 m² of offices, generating a significant traffic of people, which has contributed to a successful pre-sale process of the club’s memberships.

Sports World Paseo Interlomas was originally an individual format club, however, this remodeling and expansion was used to extend its size and expand the offer, turning it into a family format club. The club has: basic areas such as free and integrated weight, box area, cardiovascular equipment, group classrooms, swimming pool, changing rooms, steam room and sauna; it also includes FitKidz, our exclusive area for children, among other services.

As in every Sports World club, there is a wide range of sports programs for the entire family, with state-of-the-art equipment and led by certified instructors.

With this second opening in the year, Sports World maintains its leadership as the largest chain of family sports clubs in the country, with 59¹ clubs in operation.
