

# Grupo Sports World announces the start of operations of club number 45: SW Obrero Mundial, in Mexico City

**Mexico City. September 1st, 2015 – Grupo Sports World, S.A.B. de C.V.** ("Sports World", "SW", "the Company", or "the Group") (BMV: SPORT), the leading operator of family fitness clubs in Mexico announced today the start of operations of club number 45, Sports World Obrero Mundial, in Mexico City, with more than 750 sold memberships during the pre-sale process.

This club is located inside the shopping mall known as "Acora Delta" on Av. Obrero Mundial #196, at the corner with Av. Monterrey, in the Piedad Narvarte neighborhood. The club is ideally located in a housing zone with a high population density and a strong demand for fitness services, and on one of the major avenues in the area with high vehicular traffic.

Sports World Obrero Mundial is a family club so the facilities include free and controlled-weight areas, cardio equipment, group classrooms, a semi-Olympic swimming pool, dressing rooms, steam room and sauna. It also offers the FitKidz area designed exclusively for children, where they have their own classrooms and independent dressing rooms. The facility provides a wide variety of sports with state-of-the-art equipment and programs, led by certified coaches.

Sports World has opened 31 clubs since it held its IPO in October 2010, and has consolidated itself as the leading family sports club chain in Mexico with 45<sup>1</sup> clubs in operation and 2 more under the process of construction and membership pre-sale. The Company continues expanding and strengthening its footprint in Mexico City and its Metropolitan Area as well as in other cities. Currently, of the total 47 Sports World clubs, 36 clubs are located in Mexico City and its Metropolitan Area and the remaining 11 are in other cities in the country.


