

GRUPO SPORTS WORLD ANNOUNCES THE OPENING OF ITS CLUB SW PARQUE SAN ANDRES

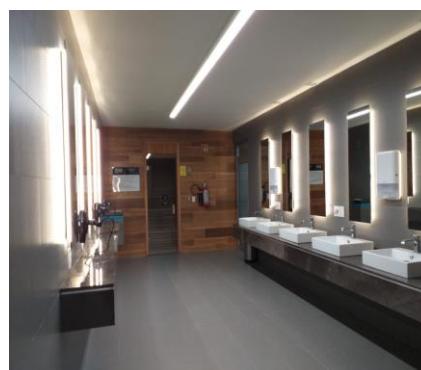
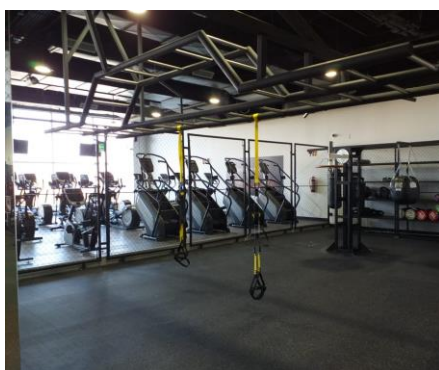
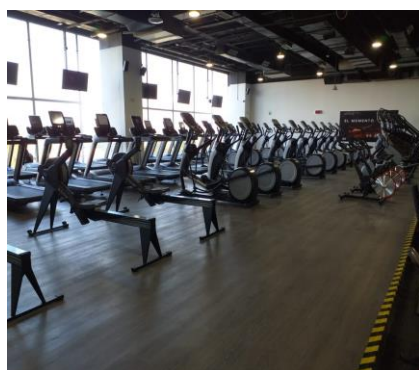
